Collective Impact Framework</b>	<p>Alysia Haddox spoke in great detail about reaching out to parents about the Protective Factors;</p> <ul style="list-style-type: none"> <li>• <b>Concrete Support:</b> One parent stated perhaps we should say “realizing” your concrete support. She said that realizing your concrete support starts at home, and parents should realize that the support they need is out there.</li> <li>• <b>Social and Emotional Competence:</b> Parents also stated that it starts at home also; parents need to have the knowledge to be aware of and know the signs of someone in need or in a bad state of mind.</li> <li>• <b>Social Connections:</b> Parents should have different activities with their children in the am and in the pm. This she says will keep them socially connected and keep their little minds busy.
