Classroom Lead Teachers (*NC Pre-K classrooms in private child care centers or Head Start; MECK Pre-K, or Developmental Day programs*) that hold one of the licensure types listed below and enrolled with the EES Unit are required to submit unofficial college transcript(s) within 10 days of the close of each semester.

NC Professional Educator Licenses Expiring June 30, 2021 and June 30, 2022

Check the license below that you hold and submit unofficial college transcript(s) to the EES Unit **IMMEDIATELY**. Submission of the unofficial college transcript(s) validates the progress of coursework completed for the 2020-2021 school year.

- Lateral Entry BK License expiring (June 30, 2021 and June 30, 2022***)
- *** Lateral Entry License holders expiring in June 2022 must plan to enroll in their final courses to satisfy the RALC Plan of Study requirements Fall 2021. All coursework and evaluations must be finalized by March 1, 2022 to allow the RALC ample time to clear the laterals by 6/30/2022 deadline.

 - Provisional BK/Pre-K Add-on License

Submission Due Date to the EES Unit

Monday, January 4, 2021 is the official due date.

- The unofficial college transcript(s) must be submitted to the EES Unit prior to or on Monday, January 4, 2021.
- Failure to meet this requirement will impact licensure support provided by the EES Unit and jeopardize employment for the 2021-2022 school year.
