Family Connects North Carolina, Southeastern Region is a Partnership for Children of Cumberland County program and serves families with newborns in Cumberland, Hoke, and Robeson counties. The Partnership's vision is to live in an economically prosperous community where families are successful and children thrive. Our mission to achieve this vision is to be the driving force to engage partners to achieve lasting positive outcomes for all children, beginning at birth.

We focus on support for families with children birth to 5 years old. Our priorities are to provide services and supports that Advance the Well-being of Children, Strengthen the Early Care Early Education System, and empower families.

**Committee purpose:** The Committee's objective is to successfully support the Family Connects North Carolina, Southeastern Region program by providing leadership, community involvement, engagement, and sustainable funding.

**Committee principles:** The Committee collaborates with community partners who seek to ensure the program's success in our catchment area. The primary roles are to provide advice and support on decisions affecting the program implementation and sustainability in key areas such as:

- Community connections
- Sustainability

- Cultivating supporters
- Aligning resources

The program is a collaboration between the Partnership for Children of Cumberland County, the Hoke County Partnership for Children and Families, the Robeson County Partnership for Children, Family Connects International, and our nursing partner, Carolina Collaborative Community Care (4C).
