Providers should only submit exception requests <u>after</u> completing attendance, and all forms should be in Ready to Submit status.

When a child doesn't have enough days of attendance to receive full payment for the month, an exception for that child's attendance may be requested under certain circumstances. Site Administrators must submit supporting documents (e.g., written justification from a medical professional, email communications with the family regarding a family emergency, etc.). Documentation will be used for monitoring purposes by DCDEE. An education service must be provided to the child in these circumstances and may include a hospital visit, home visit, remote learning services, etc. NC Pre-K Guidance Section: C.
